How to determine the amount of your contribution (your college)?

You are a developer and/or wind energy operator in France :

Your level of contribution depends on the Cdev coefficient given by the formula :

$(\text{MW in operation}) + (\text{MW in development} \times 0,5)$.

The sum of the number of MW in operation for own account and operated by a third party is used.

You are a turbine operator: your level of contribution depends on the Cturb coefficient given by the formula:
 $(\text{MW installed in France before 2020} \times 0,3) + (\text{MW installed in France in 2020} \times 0,7)$.

Members who join over the course of the year, must pay:

- * 100 % of the subscription fee when their membership is validated by the Board of Directors, which is held from January 1st to June 30th.
- * 60 % when their membership is validated between July 1st and September 30th.
- * 30 % when their membership is validated between October 1st and December 31st.
